## **Roles of Anti Ragging Committee**

- 1. To Prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities.
- 2. To root out ragging in all its forms from institution by prohibiting it by law, preventing its occurrence by following the provision of these Regulations and punishing those who indulge in ragging as provided for in these Regulation and appropriate law in force.
- 3. To monitor and oversee the performance of anti-ragging squad in prevention of ragging in the institution.
- 4. To publicize to all students and prevalent directives and the actions that can be taken against those indulging in ragging.
- 5. To take all necessary measures for preventions of Ragging inside the Campus / Hotels.

# **Roles of Anti Ragging Squad**

- It shall be the duty of the Anti-Ragging squad to be called upon to make surprise raids on hostels and other places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places.
- 2. It shall also be the duty of the Anti-Ragging Squad to conduct on-the-spot enquiry into any incidents of ragging.
- 3. To consider the complaints received from the students and conduct enquiry and submit report to the Anti-Ragging Committee along with punishment recommended for the offenders.
